1. Discussion – fiscal year 2018-19 proposed budget

Mr. Skof presented narrative on 2018-19 proposed budgets. Commissioner Robinson inquired about transfer adjustments to be equal and Mr. Skof they will be on April 30.

Commissioner Robinson inquired about Recreation budget adjustments and Special Recreation for building repair. Mr. Skof stated that was for ADA compliant doors at the Club House and Pavilion.

Commissioner Robinson inquired about presented Golf and Food & Beverage revenues and expenses. Mr. Monroe stated the budget numbers presented are more realistic than those given in the past and staff are working to monitor payroll and all spending and to try new ideas to generate revenue. Commissioner Robinson inquired about volunteers. Mr. Monroe stated there are six volunteers for the starter/ranger positions.

Commissioner Semasko asked if trees that have been cut down that were replaced. Mr. Winter stated they have not, but will look into replacing them. Commissioner Semasko suggested replacing some trees every year.

Commissioner Robinson asked if there were any additional suggestions for the Hamlet Park land the City wants for their water tower. Ms. Cowart stated the preliminary items include:

- 1. Construction of a water line from the tower to the pond at Foss Park Golf Course
- 2. Reduction of water rates for Foss Park District
- 3. Cash for the purchase of land
