- 1. Business Office

Ms. Cowart stated the handicap parking spaces in the lot of the Community Center will be repainted and get new signs.

Mr. Skof stated he received an email that the State of Illinois will be sending the money for the reimbursement park grants for Angel Park (\$41,000.00) and Boak Park (\$6,800.00).

a. Operations: Mr. Monroe reported the Foss Park Amateur is scheduled for the end of the month and staff have discussed winter hours of operation that include 9 am to 9 pm, Monday through Friday and closed on the weekends with the exception of rentals. He continued the staff is looking to promote daily week day lunch specials and happy hour during the winter months. Mr. Monroe stated new gas lines for the new kitchen equipment needed to be purchased for installation and the dryer in the basement needs replacement that is an estimated cost of \$4,700.00.

a. Operations: Ms. Cowart reported the following:

<u>Child Care (Ms. Tate):</u> Still working on recruiting kids for Latchkey and fliers were distributed to AJK, Green Bay, North and LEARN.
