ALL COMMITTEES

Business Office:

- Operations: Mr. Skof presented three estimates for the tennis court repair at Twin City. He continued a proposed budget has been presented and must be on display for 30 days before approval. Mr. Skof stated the tax levy needs to be discussed at the beginning of October.
- Commissioners' Scholarship: Commissioner Wyatt stated the scholarship application is still being worked on.
- Storage rentals: Commissioner Dixon stated the park district is still paying for the storage unit and the furniture should be removed and used. Mr. Skof stated there is a variety of furniture in the storage unit. Commissioner Dixon stated there is a conference table that can be used. Ms. Cowart stated there is a new front desk there also. Commissioner Dixon asked for the cost of the storage unit. Mr. Skof stated \$125 per month.
- Bond update: Mr. Skof stated Mr. Phillips has stated there is no change and asked about cash position.
 Mr. Skof stated if the 2016 payment was made and abated taxes coming up this fall and then do the rollover. Commissioner Wyatt asked why bonds were refinanced. Mr. Skof stated to get the rollover bond back. Commissioner Wyatt voiced concerns on the percentage rates.

Parks:

- Beach Project: Ms. Cowart stated she spoke to Mr. Shabica and the permits need to be taken care of
 with the Army Corp of Engineers. She continued that Mr. Shabica recommended working with
 Congressman Dold's office. Commissioner King stated she will get in contact with General Bostick.
- Operations: Commissioner Dixon stated that the signs have been finalized for the parks.

Golf Course:

 Operations: Mr. Monroe stated there is a concert on August 7 that the park district could possibly vend the liquor. He continued with the upcoming golf outings (North Chicago Community School District, St. Basil's Church and Miggy Smalls). Mr. Monroe presented the eBay summary. Mr. Herring presented a written report that included a new position of a bar lead and menu pricing/items along with drink prices. Commissioner Wyatt asked if there is money in the budget for this position. Mr. Monroe stated this position would take the place of the Assistant Manager position that was not filled. Commissioner Dixon suggested the position be part time and there is a lot to consider with the possibility of the position starting next year. Commissioner Johnson clarified this position is not an immediate need, but the night time activity is increasing.

Commissioner Wyatt questioned the cost of goods report and the golf round report for commissioners. He stated he has not golfed, but has rounds credited to his name. Mr. Monroe stated he would look into both items and get the information to the board. Commissioner Dixon stated Mr. Monroe should handle the problems with staff in the Clubhouse and registering golfers.

Commissioner Johnson Mr. Winter has submitted the estimates for fixing the storm drain, one for \$8,000 and one for \$21,000. He continued that the bid for \$8,000 includes landscaping and should be looked at.
